When the glazing unit incorporates 'ESG Pyrotech' glass, the product name changes to 'ESG Pyrotech Secure' followed by the security rating. For example, 'ESG Pyrotech Secure 001'.
- 2. Each glazing unit incorporates a 6 mm thick toughened glass layer on the non-attack face of the glazing unit which may be replaced by thicker toughened glass up to 19 mm thick, float glass between 6 mm and 19 mm thick, heat strengthened glass between 6 mm and 19 mm thick or 'ESG Pyrotech' glass between 6 mm and 19 mm thick. These options may affect the nominal thickness and weight noted for the 'ESG Secure' glazing unit. When the glazing unit incorporates 'ESG Pyrotech' glass, the product name changes to 'ESG Pyrotech Secure' followed by the security rating. For example, 'ESG Pyrotech Secure 001'.

- 3. The glazing units are approved for use within double glazed units (DGUs) formed by adding a layer of float glass, toughened glass, heat strengthened glass or 'ESG Pyrotech' glass to the non-attack face. These are separated from the glazing units listed above by a spacer between 6 mm and 22 mm thick. The DGUs are therefore thicker and heavier than the 'ESG Secure' single glazing units listed. When the 'ESG Secure' single glazing units are used within double glazed units, the letters DGU appear immediately after the product's name. For example, 'ESG Secure 001/DGU'.
- 4. Use of the optional features listed may affect the nominal thickness and weight noted for the 'ESG Secure' glazing units. The approval does not cover the non-security related performance of the optional features listed. This is because they are outside the scope of LPS 1270: Issue 1.
